All,

Good afternoon Martha,

I wanted to reach out to you today about a data request that we have received from Dr. Hsun-Ta Hsu, who has received a Housing Grants Lab to help evaluate the performance of the Qualified Minor Tool developed by Flourish (please see below for details). This data has been requested before the next board meeting (and the agenda has been pretty darn full in any case), so I was wondering if it would be possible to send this out to the board for an email vote? I believe that the board previously voted to support this project, so now we are just looking for approval on the specific data requested.

Purpose	Dr. Hsun-Ta Hsu is working with the Balance of State CoC to evaluate the performance of the Qualified Minor Tool, developed by Flourish Initiative. He has a received a Housing Labs grant, and has already conducted focus groups and interviews. The current phase of the project involves quantitative analysis comparing pre- and post- dissemination of the tool, as well as comparing the counties using the tool, to those who are not using the tool. Previous studies have found that youth, and rural youth in particular have longer times between first CE assessment and exit to housing. The goal of this tool is that it can support youths obtaining housing more quickly.
