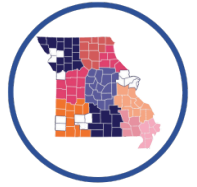

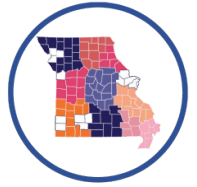

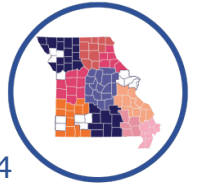


- Grants- **Reginald Jennings**

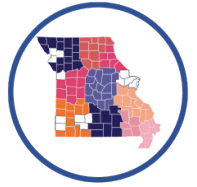
