Board Chair Sander called the Mo BoS CoC Board of Directors meeting to order by virtual meetings on Thursday September 26th, 2024 at 11:07 am. Secretary Wilson completed roll call. Quorum present.

Approval of Agenda motion made by Utterback and second by Gosnell. Motion carries.

Approval of Minutes, August 22, 2024 motion by Poitras, second by Gosnell. Motion carries.

NAEH Research Project Update: Presentation provided by NAEH regarding progress of project for assessment tool and meetings. Slides will be provided. Concerns about NAEH not being able to use HMIS data due to not housing enough people, and what data will be used, and is this objective data. Kemna reported DMH housed 89 households in 2023 and 2024 and Utterback reported that Boone County housed 90 chronic homeless from July 2023 to April 2024.

CoC Full Membership Meeting—Looking at possibly meeting on 10/23 or 10/16 for next CoC Full Membership meeting. All CoC meeting will be held virtual, following the same schedule and must be completed before NoFo. Membership meeting is planning to hold meeting on Wednesday 10/16. Motion made to hold all CoC Meeting virtually on Wednesday 10/16 made by Poitras, second by Gosnell-Hopkins. Motion carries.

Regional Board Seats: 3, 4, and 8—Region 8 voted to for Sharon Cobb to remain, Region 4 votes on 10/17. Region 3 needs to vote, October is the deadline.

Contracted CoC Administrator—Job description has gone out. CPSEMO does prefer they contract directly to be able to pay the person and the CoC won't have to be involved in payment. Deadline for applicants to apply is 10/1. Discussion of where else to post the job description to ensure position gets filled.

YAB Report—Discussion of Youth Action Board committee and how they will be supported by the CoC. The YAB currently meets every other week and are compensated, and discussion held how to compensate them moving forward with our current funds. Viewed current planning grant balance to identify if Planning Grant funds could be paid. Concerns brought up about the YAB being under the CoC and the CoC being able to take that on and facilitate YAB meetings (every other Monday night). Discussion of if YAB votes to be under the CoC, that board would suggest YAB stay under former lead agency until the CoC has a new lead agency. Former lead agency gave 60 days notice for YAB to move under CoC, deadline is 10/1. The YAB has not yet made a decision to move under the CoC or not, and discussion suggested letter be sent to former lead agency requesting an extension of time as YAB has not yet decided and the CoC is unsure if they can facilitate this committee at this time. Suggestion of even if YAB stays under former lead agency, they still attend CoC committees/etc and members also join the Youth Services Committee. Discussion of also outlining seats for them on all the CoC committees. The next YAB meeting is Monday 9/30 at 6:30 pm. Gosnell-Hopkins and Sander plan to attend the meeting. HUD requires there be a YAB if the CoC is receiving YHDP funds, both options that have been discussed today are compliant with HUD requirements for this. Suggestion to form YHDP workgroup to discuss issues with YAB/figure out a plan. The board discussed encouraging YAB members to attend all CoC committee meetings and will relay this to the YAB on Monday 9/30.

Motion to attend YAB meeting Monday 9/30 and explain to them the CoC is unable to facilitate the transfer of the YAB from CPSEMO to the CoC at this time . The CoC can revisit this when the CoC has a lead agency and will look into how to designate committee membership seats to YAB members made by Kemna and second by Poitras. Opposed: Henrion. Motion passes.

Ranking and Prioritization Policy: Question if the board needs to take action to specify that YHDP are exempted from scoring and needs to be removed from Tier 1. Information provided our current policy is accurate and no action needs to be taken.

Planning Grant: Draft of planning grant was sent out without the budget. Coleman reported she would be able to get the budget to the board by Monday 9/30. Board members task before next Friday 10/4 is to review planning grant, budget and provide feedback. Sander will call for a vote to approve the week of 10/7.

Consolidated Application: Poitras suggested looking at previous information/applications for assistance and to look for where the CoC scored low. Date the board would like to see the first draft of the consolidated application is 10/11/2024.

At-Large Seats;:What date does the board want to have at-large applications back by. At-large seats will be voted on in early December. Suggestion to send out at-large board seat applications by 10/15 with due date of 11/8. Discussion of who to review at-large board seat applicants. The at-large board seat applications will be reviewed by the Membership Committee.

HMIS Lead Agency Report: HMIS annual renewals have been sent out and are due by 10/4. Staffing updates, Tessa Cook left ICA and are looking for system administrators. ICA is also getting ready for fiscal reporting season.

Committee Reports: Coordinated Entry committee created CE cares committee to look at issues with coordinated entry. One of the main concerns is the non-working non HMIS list.

Point in Time Count Date: Point in Time Count suggested to be 1/22/2025. Motion for the CoC PIT count to be 1/22/2025 made by Utterback, second by Jennings. Motion carries.

Motion to adjournment at 2:15 pm by Gosnell-Hopkins, second by Cobb. Motion carries.
